Regulation No: USF 1.005

TITLE: Undergraduate Catalog of the University of South Florida

Summary of Amendments:

The Undergraduate catalog includes information on admissions, articulation, degree requirements, curricula offerings, and facilities. The 2009-10 proposed amendments to the Undergraduate catalog have been reviewed and approved by the respective departments; the Undergraduate Council; and Undergraduate Studies. Following are amended Regulation USF 1.005 and a summary of the major proposed revisions to the Undergraduate catalog.

Major amendments to the 2009-10 Undergraduate Catalog include implementation of the new general education course structure approved as part of USF's 2005 Southern Association of Colleges and Schools (SACS) review; and the recent restructuring of the College of Arts and Sciences, the College of Visual and Performing Arts, and the College of Behavioral and Community Sciences.

**SUBJECT: UNDERGRADUATE CATALOG OF THE UNIVERSITY
OF SOUTH FLORIDA**

(1) The University of South Florida system publishes the Undergraduate Catalog (2009-2010), incorporated by reference herein. The Undergraduate Catalog establishes and reflects undergraduate admission and degree requirements as well as provides general information regarding the USF system, University community, curricular offerings and facilities available to students, faculty and staff of the USF system. In addition, the Catalog contains the academic calendar as set by the USF system within the general guidelines of the Board of Trustees.

(2) In the event of conflict between any provisions of the Undergraduate Catalog and any regulations or policies of the USF system, the document most currently revised or adopted by the USF system shall prevail.
