Summary of Revisions

The Florida Board of Governors Regulation Development Procedure calls for a university to monitor the effects of new regulations and periodically review existing regulations to ensure they are current and consistent. USF Business and Finance and the Division of Human Resources reviewed USF system staff personnel regulations and determined that the regulations listed above should be amended to update “University” references as “USF system,” where appropriate.
