SUMMARY OF AMENDMENTS:

Proposed amendments to USF Regulation 4.0102, Tuition and Fees, include the following local fee increases, effective fall 2010.

<input type="checkbox"/>	Increase of USF Tampa Athletic Fee by \$0.62 per credit hour
<input type="checkbox"/>	Increase of USF Tampa Health Fee by \$0.24 per credit hour
<input type="checkbox"/>	Increase of USFSP Activity & Service Fee by \$0.10 per credit hour
<input type="checkbox"/>	Increase of USFSP Athletic Fee by \$0.20 per credit hour
<input type="checkbox"/>	Increase of USFSP Health Fee by \$0.38 per credit hour
<input type="checkbox"/>	Establish USF Polytechnic Health Fee @ \$0.43 per credit hour

Also proposed are Material and Supply fees (at cost) for the USF Tampa, St. Petersburg and Sarasota-Manatee campuses and Facilities and Equipment fees (at cost) for the Sarasota-Manatee Campus.

The proposed fee increases are authorized by the FL Board of Governors regulations 7.001 and 7.003 and Section 1009.24, Florida Statutes. The proposed fees were approved by the respective student fee committees and are pending approval by the USF Board of Trustees and the Board of Governors.
