## NOTICE: REGULATIONS to be REPEALED

### Summary:

The above-listed regulations will be repealed effective: March 9, 2009.

These regulations were adopted in 1980 to comply with Florida Statute 240.225 (repealed 2002), regarding the functions and duties of motor pools. Last year the Board of Governors (“BOG”) stated that with the repeal of sections 240.209(1)(3)(m) and 240.225 F.S., no regulation is required with regards to university administration of motor pools. At the same time, the BOG repealed regulation 16.002 requiring the Chancellor’s approval to acquire motor vehicles and watercraft.

In 2003, USF adopted regulation 4.02080, Purchase of Motor Vehicles, outlining USF’s authority to lease, purchase and use motor vehicles. This regulation is currently under review.
