

NOTICE: PROPOSED REPEALED REGULATION

Regulation No: 9.012

Title: College of Public Health

Summary:

Florida Board of Governors Regulation 1.001 provides that “Each Board of Trustees is authorized to promulgate University Regulations in accordance with the Regulation Development Procedure adopted by the Board of Governors,” (7-21-05). Such regulations must be consistent with law, and the regulations and strategic plan of the Board of Governors. The BOG Regulation Development Procedure requires that a University Board of Trustees monitor the effects of new regulations, periodically review existing regulations, repeal regulations as appropriate, and ensure regulations are current and consistent.

The College of Public Health has not used Regulation 9.012 in several years. The information set forth in this Regulation appears on the College of Public Health website and is regularly updated. Thus, Regulation 9.012 is not used or needed and should be repealed.

Regulation 9.012 will be reviewed by the Academics and Campus Environment Workgroup to be placed on the Agenda of the March 3, 2016 Board of Trustees Meeting.

I. PURPOSE & INTENT

The Catalog establishes and reflects admissions and degree requirements. Curricular offerings and facilities available to students, faculty and staff at the University of South Florida College of Public Health are presented. In addition, College of Public Health Graduate Degree Programs are described in the USF Graduate Catalog that is incorporated in USF Regulation 1-009.

B. In the event of conflict between any provisions of the Catalog of the College of Public Health and any other regulations of the University of South Florida, such other regulations of the University of South Florida shall prevail.
